## INTRODUCTION

I, Kanwar Karan Singh, Chairman of the House Committee on Salary & Other allowances of the Members of Delhi Legislative Assembly, having been authorized by the committee to present its Report, do hereby present the First Report of the committee.

The meeting of the House Committee on Salary and other allowances was held on 7<sup>th</sup> August, 2009 and the committee decided to examine various points relating to the duties being performed by the highest democratic institutions of not only India, Lok Sabha, but also of the world, House of Commons, so that the elected representatives of Delhi may emulate and discharge their liabilities towards electorates and Government more efficiently. The Committee considered the Report in its meetings held on 15<sup>th</sup> December, 2009.

The Committee wishes to place on record its appreciation of the valuable assistance rendered by the Officers and Staff of the Assembly Secretariat during its meetings as also in the preparation of the Report.

The Members of Legislative Assembly of the National Capital Territory of Delhi (Salaries, Allowances, Pension etc. (Amendment) Bill, 2009 regarding substitution of Section 3 "Payment of Pension" to Hon'ble Members was passed by the House on 22.06.2009. The House was of the unanimous view that a House Committee be constituted for examining the facilities being given to Members Legislative Assembly in the neighbouring States so that the Members Legislative Assembly of Delhi Legislative Assembly might get the same for discharging their duties towards electorates more efficiently. A Motion was moved by the Chief Minister for referring the matter to a House Committee for examination of facilities being given to the Members Legislative Assembly in the neighbouring States. The Motion was passed unanimously and an adhoc Committee was constituted.

Sh. Kanwar Karan Singh, Member Legislative Assembly was nominated as Chairman of the Committee by the Hon'ble Speaker constituted for examination of various



aspects of facilities being given to the counterparts of Members Legislative Assembly in other States.

In the very beginning the Committee went through the functions and duties of the Members of Parliament of the highest Legislative Bodies of the country i.e. Lok Sabha and the world i.e House of Commons, as under so that the elected representatives of Delhi could emulate the same and render service to the public and Government to the optimum and more efficiently.

Legislatures (Parliaments) all over the world are people's institutions par excellence. Parliamentarians represent the will and the voice of the people of their respective constituencies. People look up to their representatives for taking up their concerns with a view to meeting their aspirations. They are the link between the people and the Parliament.

The Parliamentary democratic form of governance which India has adopted is modeled after the British Parliamentary system.

In U.K. the House of Commons consists of 646 elected Members each one of them representing a different area. The people elect M.P.s to represent their interests and concerns in the House of Commons. The work or responsibilities of the Members can be split into three segments:-

1. **Working in Parliament:-** Their work in Parliament include :
  - (i) Legislation:- debating and voting on new laws or Amending Bills.
  - (ii) Discussing and voting on Budget supplies and other financial measures.
  - (iii) Raising issues affecting their Constituencies through various procedural devices.

- (iv) Enquiring into the working of the Government, by asking Questions and supplementaries there on.
- (v) Oversight or surveillance of the executive while working in Committees of the House which look at the issues in details from setting the policies and implementation of laws and justification and propriety of new laws to wider topics like human rights.

2. **Working in their Constituencies:-** M.P.s often hold surgeries in their office where local people can discuss the matters that concern them . Though there are limitations for an M.P. to help but the people expect their representative to help them. The MPs also attend functions visit schools and businesses and generally try to meet as many people as possible. This gives M.P. is further insight into the issues they may discuss when they return to the Parliament.



3. **Working for their Political Party:-** Members also work for their respective parties in various capacities. If they belong to ruling party some of them become Government Ministers.

### **Function of Parliament in India:**

Some of the cardinal functions of the Parliamentarians may be described as follows:

1. **Law making:** - is the traditional function of Parliament and it is done through the Parliamentarians. That is why they are also called lawmakers. Parliament passes laws on a wide range of subjects allotted to it under Union and Concurrent lists under the Seventh Schedule of the Constitution. The parliamentarians discuss and scrutinize the bills, rules and resolutions etc and put the seal of the approval by the Parliament.
2. To pass the Budget and supplies and other financial measures.

3. **To ensure the administrative accountability to Parliament:** - Parliamentary scrutiny is exercised by the Members through various devices like Questions, motions, Discussion etc and Committees. They enquire and examines whether the administration has acted in conformity with its obligations under approved policies, through the various procedural devices and the well-established network of Committees.

4. **Representational and Grievances Ventilational Role:**

A member of Parliament views his primary duty to be that of representing his people and giving expressions to their difficulties, problems and grievances and seeking their removal and redressal.

5. **Their responsibility towards their Constituency: -**

Members of the Parliament owe their status of M.P. to the people who elect and send them to Parliament. So they have to have a regular dialogue with their people to discuss and understand their problems. They also have to help their constituents in whatever way possible in solving their problems. Being in the National Capital as the representatives of their people, many a times the MPs have to provide lodging & boarding facilities to the people visiting them. They have also to attend so many social and official functions in the constituency as well as in the National Capital.

Parliament is not merely a law making body, it has acquired the status of a multi-functional institution today.

For discharging the aforesaid duties there are certain powers and privileges bestowed in the legislatures are secured under the provisions of the Constitution.



**Article 194 of the Constitution provided that :-**

- (1) Subject to the provisions of this Constitution and to the rules and standing orders regulating the procedure of the Legislature, there shall be freedom of speech in the Legislature of every state.
- (2) No member of the Legislature of a State shall be liable to any proceedings in any court in respect of anything said or any vote given by him in the Legislature or any committee thereof, and no person shall be so liable in respect of the publication by or under the authority of a House of such a Legislature of any report, paper, votes or proceedings.
- (3) In other respects, the powers, privileges and immunities of a House of the Legislature of a State, and of the members and the Committees of a House of such Legislature, shall be such as may from time to time be defined by the Legislature by law, and until so

defined [shall be those of that House and of its members and committees immediately before the coming into force of Section 26 of the Constitution (Forty-fourth Amendment) Act, 1978].

- (4) The provisions of clauses (1), (2) AND (3) shall apply in relation to persons who by virtue of this Constitution have the right to speak in, and otherwise to take part in the proceedings of a House of the Legislature of a State or nay committee thereof as they apply in relation to members of that Legislature.

**Article 195 of the Constitution provided that :-**

Members of the Legislative Assembly and the Legislative Council of a State shall be entitled to receive such salaries and allowances as may from time to time be determined, by the Legislature of the State by law and, until provision in that respect is so made, salaries and allowances at such rates and upon such conditions as were immediately before the commencement of this Constitution applicable in the case of members of the Legislative Assembly of the corresponding Province.

One of the main functions of the legislators is to make law. Legislation is a technical job. In the given circumstances where the level of literacy of the Indian masses is at miserably low ebb, it should be reasonably expected that our legislators, or a sizeable proportion of them, must be lawyers, or even educated at a particular level. But the House does not need lawyers for creating law; it is neither their job to create law,- their job is to interpret law. Creation of law must be left to the elected representatives of the people. Most of them may not be expected to know the fine mechanism required to enact a law. What they are supposed to do is that they must know the pulse of the people upon whom the law is to operate so that they could decide as to what type of a law is required to be enacted. They should also be in a position to throw their suggestions, if any, in regard to the salient features of the proposed piece of legislation with a view to improve upon them.



The Rule and Regulations in Delhi Legislative Assembly were borrowed from the Uttar Pradesh Legislative Assembly in 1993.

The Committee also observed that Article 195 of the Constitution provided that salary and allowances would be given to the members of the Delhi Legislative Assembly as determined by the House. Section 19 of the Constitution (Sixty nine Amendment Act, 1991) also provides that Members of the Legislative Assembly shall be entitled to receive such salaries and allowances as may from time to time be determined by the Legislative Assembly.

The Committee was of the unanimous view that it should not only concentrate merely on hiking the salary and allowances of the Hon'ble Members but also give suggestions to ameliorate the working conditions of the elected representatives so that they may render optimum best service to the public.

The Committee observed that the elected representatives of Delhi Legislative Assembly had to work round the clock for redressing the grievances of public. They are not affluent and can't do any business to maintain their families. Therefore it is imperative that their salary, allowances and other facilities such as medical and traveling, allowances etc. should be enhanced periodically and automatically on the pattern of Civil Servants. The Committee was of the view that some mechanism should be evolved by the Government in this regard so that there may not be need of bringing Bills again and again in the House. The committee also observed that Members Legislative Assembly should be provided all the essential facilities such as Laptops, Mobiles etc. at their offices so that they can serve the public most effectively. The Medical facilities being provided to the Members Legislative Assembly are not sufficient and reimbursement of medical bills is made only in referral cases by the Government Hospitals. The Committee directed to explore possibilities of Medical Insurance cover for Members Legislative Assembly.

The Ex Member Metropolitan Councils, Members of Legislative Assemblies should be treated at par in grant of pension to them and one set of rules should be applied in this regard. The provisions of payments of pension to the family members/dependents of the deceased Ex-Member Metropolitan Councils, Members of Legislative Assemblies be also made.

The Committee held its meeting on 7<sup>th</sup>, August, 2009. The Committee decided to conduct a Study Tour to the States of Punjab, Haryana and Goa and examine the facilities which were being given to the Members Legislative Assembly of those states for discharging their House duties and towards electorates more efficiently. Later on appreciating economy drive, as an austerity measure, the Committee rescinded the Study Tour to these States and decided to request all the Legislatures for sending the details of facilities and allowances being given to its Members Legislative Assembly by post. The materials from the States have been received from the States and the Committee scrutinized the same as under:-



**1. LOK SABHA :**

Article 106 of the Constitution provided that :-

Members of either House of Parliament shall be entitled to receive such salaries and allowances as may from time to time be determined by Parliament by law and, until provision in that respect is so made, allowances at such rates and upon such conditions as were immediately before the commencement of this Constitution applicable in the case of members of the Constituent Assembly of the Dominion of India.

There are 545 Members of Parliament at present out of total strength of 552. There are 34 Cabinet Ministers, 7 Independent charge Minister and 38 Ministers of State. The facilities and allowances given to a MP are at Annexure-A.

The Committee observed that as compared to Legislators of above states, the Members of Delhi Legislative Assembly (DLA) perform more strenuous duties towards their electorates by attending Meetings of the Committees and Sessions of the House simultaneously. In the above Legislatures, the Members Legislative Assembly while attending Meetings of the Committees and Sessions of their respective House, they don't have to interact with their electorates for redressing their grievances so frequently being far away from their Constituency. But the Members Legislative Assembly of DLA are more accessible to their electorates. They not only devote time to attending the Meetings of the Committees and Sessions of the House but also at the same time spare their time out of their hectic schedule for interacting and redressing the grievances of their electorates.

The Committee was also of the unanimous view that after performing the above duties, the Members of DLA are left with no time with them for running their business to eke out their livelihood. The Delhi being the capital is the most expensive City in the country. The Committee decided that the Members Legislative Assembly of DLA be given the same facilities and allowances as are available to their counterparts in the above States so that they could discharge their duties towards the electorates and in the House more efficiently and fulfill the aspirations of the public and the Government.

## **2. DELHI STATE :**

Section 19 of The Constitution (Sixty Ninth Amendment) Act, 1991 provides that :-

Members of the Legislative Assembly shall be entitled to receive such salaries and allowances as may from time to time be determined by the Legislative Assembly by law and until provision in that behalf is



so made, such salaries and allowances as the Lieutenant Governor may, with the approval of the President by order determine.

There are 70 Members in the Delhi Legislative Assembly out of which there are 7 Ministers. The facilities and allowances given to a Member are at Annexure-B.

### **3. GOA STATE :**

There are 40 Members in the Goa Legislative Assembly out of which 10 are Ministers. The details of allowances and other facilities being given to the Members are at Annexure - C. The Committee scrutinized the same and observed that an Member of Goa Legislative Assembly is given Constituency and Conveyance Allowances three times and remuneration for personal staff is almost double than the same which are paid to a Member of Delhi Legislative Assembly whereas they perform the same duties.

#### **4. PUNJAB STATE :**

There are 117 Members in the Punjab Legislative Assembly out of which 35 are Ministers. The details of allowances and other facilities being given to the Members are at Annexure - D. The Committee scrutinized the same and observed that apart from the allowances which are given to a Member of Delhi Legislative Assembly, a Member of Punjab Legislative Assembly is also given Consolidated and Compensatory Allowances and a free telephone, the call charges of which are paid by the Punjab Assembly Secretariat. Both the Members of Punjab and Delhi Legislative Assemblies perform the same duties.

In Punjab Legislative Assembly, pension is given to a Member @ Rs. 5000/- p.m. for the first term & Rs. 2500/- p.m. for every subsequent term. After attaining the age of 65, 75 and 80 years an increase of 5%, 10%, 15% of the basic pension

## 5. HARYANA STATE :

There are 90 Members in the Haryana Legislative Assembly out of which 8 are Ministers, 3 are Ministers of State and 9 are Chief Parliamentary Secretary. The details of allowances and other facilities being given to the Members of the above State are at Annexure – E. The Committee scrutinized the same and observed that a Member of the above state is given Constituency and Daily Allowance double than the same which are paid to a Member of Delhi Legislative Assembly whereas they perform the same duties.

The elected representatives of Delhi Legislative Assembly had to work round the clock for redressing the grievances of public. They are not affluent and can't do any business to maintain their families. Therefore, it is imperative that their salary, allowances and other facilities such as medical and traveling allowances etc. should be enhanced automatically on the pattern of officers. Some



mechanism should be evolved by the Government in this regard.


The Members Legislative Assembly should be provided all the essential facilities such as Laptops at their offices so that they can serve the public most effectively. The Medical facilities being provided to the Members Legislative Assembly are not sufficient and reimbursement of medical bills is made only in referral cases by the Government Hospitals. The Members wanted to explore possibilities of Medical Insurance cover for Members Legislative Assembly.

## **RECOMMENDATIONS**

1. A mechanism be evolved by the Government for regularizing the salary and allowances of Members of Delhi Legislative Assembly periodically.
2. It is recommended that features of facilities and allowances etc. of the Goa and Punjab Assemblies should be adopted for the Members of Delhi Legislative Assembly (Annexure-C & D).
3. Members be provided a conveyance, computer, laptops, printer, mobiles and other useful office devices, during the tenure.
4. Medical facilities as available to the Group A Officer (Highest Grade) of Government be given to the Members of Delhi Legislative Assembly.

5. Pension & Medical facilities be provided to the ex-Members.
6. Family pension facilities should be provided to the family of deceased Members.
7. Pension with all provisions should be on similar pattern in case of the Ex-Members of the present Assembly, erstwhile Metropolitan Council and First Assembly (1952-56).
