Responsibility before execution of work

 Merely issue of AA/ES does not confer the right for violation of norms as decided and circulated for carrying out restoration/improvement of works.

2. No deviation from the prescribed specifications, quality and quantity (ies):
There shall be no deviation in the proposed work unless and until it is assentially required and that shall be undertaken only after due compliance of all the requisite codal formalities and in consonance with the provision/guidelines as laid down under GFR, FRSR, DFPR, instructions of CVC, Finance Department issued from time to time. Any deviation beyond the permissible limit as per CPWD Works Manual shall not be carried out without the approval of the Competent Authority.

The executing agency during the course of execution/construction will ensure that the specification of items, their quality, quantities and proportion of the quantities as well as measurements in respect thereof as used in the project during the course of construction are the same on the basis of which estimates have been prepared and that there is no deviation whatsoever.

Due diligence has been exercised in the formulation of instant scheme/proposal for the execution of work. The proposed scheme is new one and no work of the same/similar nature has been executed by this department prior to the proposed one except in those cases where the life of previously executed same work's life has been completed.

For fulfillment of the aforesaid requirement, Supervisory Officers/ Engineers during the course of execution/construction shall carry out regular inspections and ensure that specifications regarding quality, quantities and proportions/ measurements thereof are being adhered to scrupulously.

4. <u>Compliance of statutory rules and regulations:</u>

Work shall be awarded after completion of codal formalities as per the provisions of CPWD Work Manual, GFR-2017 and instructions/guidelines etc. issued by Finance Department/ CVC from time to time.

Bids shall be invited for the consolidated work which shall not be sub-divided in any manner for the purpose of tendering. Work shall be awarded through competitive bidding only. Performance security shall be obtained from successful bidder to ensure execution of the contract as per the provisions of GFR-2017, CPWD Manual and instructions/guidelines etc. Issued by Finance Department / CVC from time to time. Work shall be awarded within the scope and financial limits of AA & ES granted by the competent Authority. In case the L-1 Bid is over and above the sanctioned cost of the project, fresh tenders may be invited. If the proposal for revision of estimates may be brought/ submitted before the competent authority clarifying as to whether the rates are reasonable of not, keeping in view the prevalent market trend/rates.

Work shall be completed within the given time-frame and within the sanctioned cost and as per CPWD Work Manual/ GFR 2017. Escalation in cost will not be allowed. The expenditure shall be restricted to the approved detailed estimates of approved tender amount whichever is less. Necessary limited tenders shall be invited for this purpose from the approved registered contractors/agencies/parties in the panel of I&FC Depttt., as per the departmental guidelines. The Accounts functionary posted in the Division shall be associated as a member of the tender committee for finalizing the same and the same shall be got examined from them before seeking approval of the competent Authority.

7. Adherence to sanctioned scope of work:
The Executive Engineer shall not change the scope of work on their own. It shall be brought before the competent authority for approval, if any such change is perceived/ necessitated subsequently. The proposed development work shall be updated upon completion on the GSDL map. The proposed work does not fall within any reserve forest area/morphological ridge/ASI jurisdication. The proposed scheme has been approved by the TAC and the scheme is proposed to be executed on the department own land and it shall be free from all the hindrances.

- 8. Payment not to be released without the approval of the competent authority:

 The Executive Engineer shall not make any payment in anticipation of approval/ sanction of revised/modified estimates unless and until the same has been considered and approved by the Competent Authority.
- 9. <u>Splitting of work not permissible:</u>
 No work shall be splitted, in any manner, subsequent to the issue of the sanction. In case, it is required, the proposal shall be brought before the competent sanctioning authority for its consideration and approval.
- 10. <u>Non-Inclusion of extra item:</u>
 No extra item shall be included in the sanctioned project/ work subsequent to the sanction. Extra items, if essential, shall be included in the execution of work only after the prior approval of the competent sanctioning authority. Post facto approvals shall not be permitted.
- 11. Utilization of provision for contingency:
 The provision of contingency is meant for unforeseeable and
 unidentifiable items which can not be included/anticipated while preparing estimates for the work/project.
 Accordingly, the sanctioned provision of the project for contingencies shall be invariably utilized for the same. Personal claims on any account including conveyance, office contingencies etc. shall not be charged on works.
- 12. Financing of the sanctioned work:

 Financing for the works shall be managed by executing agency as per the provisions made in its budget for respective works allocated/ provided in different years.
- 13. Monitoring of the project:
 The Supertendent Engineer shall monitor the execution of the project and submit quarterly progress report of the project to Finance Department/ Planning Department regarding the financial and physical targets and that the specifications of items, quantity/quality of materials including proportion thereof are the same on the basis of which estimates were prepared.

Confirmation of completion of work/project:

On the conclusion of the project/ scheme, work completion certificate alongwith utilization certificate of funds and 3rd Party quality control certificate must be furnished to Finance Department/Planning Department, Secretary (I&FC) And IFA/DCA(Development) and there shall be a provision of an independent third party check for evaluation of the quality of the executed work.

No duplicacy of work by any agency: The

Executive Engineer/Superintending Engineer agency must ensure that none of the components/units/stretch (es) is duplicated in any manner during execution/award of work or at the time of payment either by it or by any other agency.

16. Guarnatee period:

Every capital asset created/ upgraded has, technically, a certain/estimated life span,. In order to ensure that the quality and quantity of the items/ material used in the execution of work is as per the standard/ prescribed specifications and that the asset so created lives its full life, Guarantee clause must be incorporated in the contract deed so that the contractor is held responsible/liable whenever any deficiency/ short coming/ break down is observed which shows that the work has not been executed as per prescribed

Fore-closer of the project is not permissible mid-way:

The project must not be scraped during the course of execution on any pretext. In case emergence of some extra-ordinary circumstances leads to such unforeseen situation of fore-closer of the project/scheme, the matter may be placed before the sanctioning authority.

Maintenance of the assets after construction:

The projects, after their completion, shall be properly maintained by the executing agency / user organization properly as per the provisions of the CPWD Manual, Government Order dated 25.07.2011, the guidelines/ instructions Issued from time to time and keeping in view the provisions of Construction-cummaintenance contracts executed, in cases where such mechanism has been adopted.

Contract with the contractor:

The executing agency shall enter into formal contract with the contractor. The contract deed should be in the standard format and should incorporate all the necessary clauses for safeguarding the interest of Government in accordance with the provisions of GFR 2017/ CPWD Manual and the aforesaid instructions/ conditions.

Availability of budget:

It may be ensured that the expenditure is to be made only subject to the availability of funds. All efforts should be made to utilize the funds efficiently & effectively as per rule. DDO to ensure that the expenditure against the project/scheme shall be booked only when the allocation of fund is available against the project/scheme.The EE CD-VIII already certified that there is no liability for the said work in the current financial year. The provisions for entire expenditure to be incurred under the said work have been projected in BE 2021-22.
