CABINET DECISION NO. 3169 DATED 12.12.2024

Subject: Mukhyamantri Mahila Samman Yojana for transfer of Rs.1000/- per month to eligible women beneficiaries in National Capital Territory of Delhi.

Decision: The Council of Ministers considered and approved the proposals contained in Para-3 (Features of the scheme) of the Cabinet Note except Para-3.4 and with the modifications of Paras - 3.2, 3.3 and 3.6 as under:-

3.2 Eligibility Criteria:

- a) Women above 18 years of age.
- b) Should be a resident of NCT of Delhi with valid Voter ID Card as on the date of this Cabinet Decision i.e. 12.12.2024.

3.3 Exclusion Criteria:

- a) Past or present permanent government employees (either in central government, state government or local bodies)
- b) Present or former elected woman public representative (MP, MLA or Councillor).
- c) Any woman who has paid Income Tax in the last assessment cycle.
- d) Beneficiaries of any of the three social security financial assistance schemes of GNCTD viz. Disability pension scheme, Old age pension and Financial assistance scheme to women in distress.

3.6 Registration Process:

For smooth implementation of the scheme, the Department may obtain approvals for any further modifications in the registration and implementation processes (which have been laid out in Para - 3.6, 3.7, 3.8, 3.9, 3.10, 3.11 and 3.12) from Minister-in-Charge concerned.

Further, the Council of Ministers decided that the Department will take necessary steps for smooth implementation of scheme including setting up of Project Management Unit.
