Prof. Vijay Kumar Malhotra moved his amendments regarding insertion of clause 38 A after the Section 38 of the Principle Act and restoration of powers to MCD as mentioned in the Constitution of India which were earlier withdrawn.  
The Bill was considered clause wise.  
Amendments of Prof. Vijay Kumar Malhotra and Shri Sahab Singh Chauhan were put to vote and rejected.  
Minister of Urban Development moved that **“The Delhi Municipal Corporation (Amendment) Bill, 2011 (Bill No. 10 of 2011)”** introduced on 30<sup>th</sup> November, 2011 be passed.  
Members of the Bhartiya Janta Party came into the well of the House and started raising slogans.
