Suspension of Member and walk out by opposition

As the Hon'ble Chief Minister stood up 14. to reply to the debate, a Member of the Congress Party, Shri Ramvir Singh Bidhuri got up to say that since his name was proposed by his party whip for speaking on the Motion, he should be called to speak before the Chief Minister replies to the debate. As the Chief Minister was already on his legs, the Chair advised the Member to sit As the Member repeatedly disobeyed the Chair and insisted on speaking, the Chair was constrained to name him. Thereafter, on a motion moved by the Minister of Legislative Affairs, Shri Rajinder Gupta which was carried, Shri Bidhuri was suspended from three sittings of the House.

All Congress Members came in the well of the House shouting slogans and protesting member's suspension and thereafter walked out.

The Motion was put to vote and negatived by voice vote as no one supported it.
