The sitting commenced with the rendition of National Song - Vande Matram.

Being the first day of the Winter Session, Hon'ble Speaker welcomed the members.

2. Hon'ble Speaker informed the House that he has received a communication from the Chief Minister stating that Shri Alok Kumar has been appointed ruling party's Chief Whip in place of Shri Ram Bhaj who had earlier resigned. Accordingly he has ordered exchange of seats between the two.

Adjournment Motion - ruling

5. Hon'ble Speaker read out the notice of Adjournment Motion received from Shri Deep Chand Bandhu, Shri Ramveer Singh Bidhuri

and others regarding serious charges of criminal nature against the Chief Minister and his relatives. The Chair ruled that the same has been disallowed because

- it raises more than one issue and is not specific; is not related to a matter of recent occurrence; the subject matter does not primarily fall within the jurisdiction of the Government and can be raised through other available procedural devices. Hence he has not given his consent to it under Rule 60.

When the opposition Members protested at the rejection of their Motion, the Chief Minister stood up to say that he would not like to shy away from the debate and would like to have discussion today itself on the issue. After some discussion the matter contained in the Resolution would be discussed as Short Duration Discussion at 3.30 p.m.

Personal Explanation

Km. Purnima Sethi giving personal explanation under Rule 275 said that some time back she had received along with a magazine "Jagriti" copies of two letters which purported to cast reflectons on her and infringed her rights as a Member of the House. She also expressed resentment that the Committee consituted to draw up security plans for Old Secretariat contained the names of Police and administrative officers overlooking the claims of elected representatives.

Hon'ble Speaker clarified the position that hehas issued orders that no Dharna be allowed in the precincts of Vidhan Sabha Bhawan by anyone.
