12.04 PM      The Chair congratulated the House on the occasion of *Nav Samvatsar* 1934.

12.05 PM      **Papers laid on the Table:**

**1. Smt. Sheila Dikshit, Chief Minister** laid the copies of the following papers (English-Hindi Version) :

Place of Election: - MLA Lounge, Old Secretariat, Delhi.

12.10 PM      **1. Presentation of Annual Budget (2012-2013):**

Smt. Sheila Dikshit, Chief Minister presented the Annual Budget for the financial year 2012-2013.

12.17 PM **The Chair named Shri Sat Prakash Rana, Hon'ble Member for his indecorous behaviour.**

12.18 PM **2. Demands for Grants:** The Chief Minister presented the Demands for Grants for the financial year 2012-2013.

**3. Presentation and Voting on the Supplementary Demands (2011-2012):** The Chief Minister presented the first and final batch of Supplementary Demands for the Financial Year 2011-2012.
