1. 2.02 PM As soon as the House assembled, Prof. Vijay Kumar Malhotra, Leader of Opposition & other Members of Bhartiya Janta Party stood up from their seat and raised the demand for constitution of a House Committee for thorough probe on corruption in recently held 19<sup>th</sup> Commonwealth Games. Thereafter pandemonium was created in the proceeding of the House by persistent demand of the Members of Bhartiya Janta Party and they stormed in the well of the House. Hon'ble Chief Minister raised point of order on the issue and Hon'ble Speaker tried to pacify the excited Members of the Opposition.
