1. 2.04 PM **Obituary Reference:**
The House made obituary reference to Dr. P.C Kaushik, Ex-Metropolitan Councillor & Ex-Member of Second Delhi Legislative Assembly and observed one minute silence as a mark of respect for the departed soul.
2. 2.10 PM The Chair welcomed Shri Vijay Jolly, Ex-Member of Delhi Legislative Assembly for his presence in the LG Gallery.

Hon'ble Speaker further stated that the Members can express their views on this issue while participating in the debate on the Budget which will last for 04 days. The Chair did not allow the Adjournment Motion.
