1. 2.05 PM Prof. Vijay Kumar Malhotra, Leader of Opposition raised the issue of price rise in Delhi.  
The Chair stated that the issue of price-rise would be discussed in the House tomorrow i.e., 30<sup>th</sup> March 2010, as already assured to the House earlier.  
Dr. Jagdish Mukhi and other Members of the Bhartiya Janta Party stood up on their seats and demanded rollback of increased taxes and subsidy be continued.
