**No. 74****2.05 PM Dr. Yoganand Shastri, Hon'ble Speaker in Chair**

1. 2.05 PM Prof. Vijay Kumar Malhotra, Leader of Opposition sought to know about the decision taken on the notice of Breach of Privilege and Contempt of the House given by him regarding pre-mature reading of the Budget document by some officers in the Officers Gallery of the House, as telecasted by various T.V. News Channels. He demanded that the aforesaid matter be referred to the Privilege Committee of the House because it was against the convention of keeping the Budget as confidential.
