Sh. Vijender Gupta, Hon'ble Speaker in-Chair

- 1. 02.03 P.M. As soon as the proceedings of the House commenced, Hon'ble Member Shri Tarvinder Singh Marwah expressed concern over the non-allotment of designated office rooms to the MLAs in their respective Constituencies with proper facilities and to the Chairpersons of various committees in Assembly Complex. He stated that the absence of such essential facilities is hindering the smooth execution of their legislative responsibilities. Shri Karnail Singh, Hon'ble Member also raised the same issue.

He urged the Government to take prompt and appropriate action in this regard.

Shri Manjinder Singh Sirsa, Hon'ble Minister assured that necessary steps will be taken by the Government expeditiously and the House will be duly informed.
