Sub: Election of 03 (three) Members to the Delhi Development Authority under the provisions of the Delhi Development Act, 1957.

Hon'ble Members are hereby informed that under the provisions of Section 3(3)(f) of the Delhi Development Act, 1957, 03 (three) Members of Legislative Assembly of NCT of Delhi is required to be elected for representation in Delhi Development Authority by means of a single transferable vote by the Members of the Legislative Assembly from among themselves of which two shall be from among the Ruling Party and one from the Opposition Party.

For this purpose, the following schedule has been fixed for receiving the nominations, withdrawal of candidature and for holding election, if necessary:-

4.	Venue of voting (if necessary):	MLA Lounge-I, Legislative Assembly Complex, Old Secretariat, Delhi-110054.
5.	Counting of votes (if necessary):	To commence from 04:00 PM of Wednesday, 26 th March 2025
