2.01 PM Dr. Yoganand Shastri, Hon'ble Speaker in Chair

1. 2.02 PM Shri Anil Bhardwaj, Hon'ble Member stated that Prof. Vijay Kumar Malhotra, Leader of Opposition had misled the House in his speech delivered yesterday during the Motion of Thanks and passed remarks against a person who was not a member of this House.
Members of Bhartiya Janta Party stood up on their seats and raised objections on the aforesaid issue.
Some Members of Congress Party also stood up on their seats.
Exchange of arguments between the Members of Ruling Party and Opposition Party.
Sloganeering from both sides.
The Chair ruled that such type of incidents were not healthy for dignity and decorum of the House. As per established parliamentary norms; name of a person who is not a Member of the House, should not be mentioned in the speeches. He requested all Members that this tradition should be followed and be taken care of in future.
2. 2.11 PM Shri Shoaib Iqbal, Hon'ble Member sought to know about the fate of the notice of Calling Attention Motion given by him regarding cancellation of Visa issued to Mr. Salman Rushdee, Resident Of Britain.
The Chair stated that the decision on the aforesaid notice would be intimated to Hon'ble Member after the Question Hour.
