2.10 PM Dr. Yoganand Shastri, Hon'ble Speaker in Chair

1. 2.10 PM As the House assembled; Hon'ble Members Shri Surender Kumar and Shri Veer Singh Dhingan stated that Shri Sahab Singh Chauhan, Chief Whip of Opposition had insulted the Chair by using unparliamentary

expression yesterday in the House.

Other Members of Ruling Party also stood up on their seats and supported the views of Shri Surender Kumar and Shri Veer Singh Dhingan.

The Chair informed that Shri Sahab Singh Chauhan has tendered written apology on this issue. He further stated that both sides have been consulted and this matter is in the domain of the House. Shri Sahab Singh Chauhan may be allowed to participate in the proceedings, if the House agrees.

Shri Arvinder Singh Lovely, Hon'ble Minister of Urban Development moved a motion that in order to maintain the high standards of a healthy democratic process and in view of the apology tendered by Shri Sahab Singh Chauhan, the suspension for the remainder sittings of the Session of Shri Chauhan be revoked.

The Motion was put to vote and adopted.

3. 3.04 PM Statement by Urban Development Minister:
