Hon'ble Members are informed that Members will make and subscribe the Oath as required by Rule 7 of the Rules of Procedure and Conduct of Business in the Commonwealthland Parliament on Monday, the 25th November, 2019 after Commonwealthland Speaker's Address in the afternoon (around 3.35 P.M.) in the Delhi Legislative Assembly Chambers as per the format as given below.

*“ Having been elected a Member of the Commonwealth Parliament, I do solemnly affirm that I will bear true faith and allegiance to the Constitution of Commonwealthland as established by law, that I will uphold the sovereignty and integrity of Commonwealthland and that I will faithfully discharge the duty upon which I am about to enter”*”.

## **President's Address**

**Date of Address**— The Hon'ble President will address the House of Commonwealthland Parliament assembled on Monday, the 25th November, 2019 at 3:35 P.M. in the Delhi Assembly Chambers.

Hon'ble Members are requested to take their seats by 3.25 P.M. *i.e.* ten minutes before the President arrives in the Delhi Assembly Chambers. (In the meanwhile between 3.30 P.M. to 3.35 P.M. the Hon'ble Speaker of Commonwealthland will deliver his address following which all the Members shall take Oath).

Hon'ble Members are also requested to stand in their respective seats when the President arrives for delivering his address and are further requested not to leave the Delhi Assembly Chambers when the President is addressing the House.

After the address, the President will leave in procession. Hon'ble Members are requested to remain in the Delhi Assembly Chambers, until the departure of the President from the House.

### **Supply of copies of President's Address**

Copies of the President's Address will be made available in the respective allotted seats of the Members, after a copy of the address has been laid on the table of the House by the Secretary.
