TERMS & CONDITIONS

- 01. Sealed quotations are invited from the reputed Firms/Institutions having GST number. The sealed quotation on the prescribed performa dully filled in and addressed to the Head of the Office/Deputy Secretary, Delhi Legislative Assembly Secretariat.
- 02. Quotation should be marked on envelope "QUOTATIONS FOR PRINTING OF 50 SETS OF HOUSE PROCEEDINGS HELD IN CENTRAL LEGISLATIVE ASSEMBLY FROM 1924 TO 1930".
- 03. The quotation must accompany with DD of Rs. 25000/-(Rs. Twenty Five Thousand Only) drawn in favour of "Secretary, Delhi Legislative Assembly" as EMD. The EMD of the all the bidders shall be refundable. Quotations without EMD shall not be entertained.
- 04. Bidders who are Government Departments/Central Public Sector Undertakings/MSME/or exempted by any Law from furnishing the EMD are exempted from furnishing the Earnest Money Deposit (EMD)/Bid Security.
- 05. The firm whose quotation will be accepted being the L-1 Bidder shall deposit Performance security for an amount of Rs. 50,000/-(Rs. Fifty Thousand Only) in any of the following forms i.e. an account Payee DD or Fixed Deposit receipt from a Commercial bank, or bank Guarantee from a commercial bank in favour of "Secretary, Delhi Legislative Assembly" within 7 days from the date of issue of award of work by this Secretariat. No interest will be payable on this amount. In case of breach of contract by the contractor, the Performance Security shall be forfeited by the government and the firm shall be blacklisted in addition to termination of the contract.
- 06. The column shall be clearly filled in ink legibly or typed and the bidders shall take care that the rate and amount may be written in such a way that Interpolation is not possible.
- 07. No advance payment will be made and the payment will be made only after completion of work.
- 08. Since the said work is required in the Secretariat on very emergent basis, the work should be executed within prescribed period of time i.e. within 15 days of finalization.
- 09. The Secretariat shall reserve the right to terminate the contract at any time if the services are not found satisfactory.
- 10. If the quality of the service/works does not found upto the mark, penalty as decided by the Competent Authority will be imposed in addition to termination of the contract.

Arbitration
