THE DELHI APPROPRIATION (NO. 1) BILL, 2012

A BILL

to authorise payment and appropriation of certain further sums from and out of the Consolidated Fund of the National Capital Territory of Delhi for the services in respect of the financial year 2011-12.

BE it enacted by the Legislative Assembly of the National Capital Territory of Delhi in the Sixty third Year of the Republic of India as follows:-

Short title.

1. This Act may be called the Delhi Appropriation (No. 1) Act, 2012.

issue of Rs. 983,67,30,000/from and out of the Consolidated Fund of the National Capital Territory of Delhi for the financial year 2011-2012

2. From and out of the Consolidated Fund of the National Capital Territory of Delhi, there may be paid and applied further sums not exceeding those specified in column (5) of the Schedule, amounting in the aggregate the sum of rupees nine hundred eighty three crore sixty seven lakh thirty thousand only towards defraying the several charges will come in the course of payment during the financial year 2011-2012 in respect of the services specified in column(2) of the Schedule.

Appropriation.

3. The sums authorised to be paid and applied from and out of the Consolidated Fund of the National Capital Territory of Delhi by this Act, shall be appropriated for the services and purposes expressed in the Schedule in relation to the said year.

STATEMENT OF OBJECTS AND REASONS

Sub-section (I) of section 29 read with clause (a) of sub-section (1) of section 30 of the Government of National Capital Territory of Delhi Act, 1991 (1 of 1992), provides for the appropriation out of the Consolidated Fund of the National Capital Territory of Delhi, of the moneys required to meet the additional expenditure charged on the Consolidated Fund and the supplementary grants made by the Legislative Assembly for the expenditure of the Government of National Capital Territory of Delhi. In pursuance of the aforementioned provisions of the said Act, it is proposed to introduce the Delhi Appropriation (No.1) Bill 2012 for the expenditure of the Government of National Capital Territory of Delhi for the financial year 2011-2012, in the Legislative Assembly of Delhi for its consideration and approval.

2. The Bill is intended to achieve the aforesaid objectives.
