THE DELHI APPROPRIATION (VOTE ON ACCOUNT) BILL, 2012

A BILL

to authorise payment and appropriation of certain further sums from and out of the Consolidated Fund of the National Capital Territory of Delhi for the services in respect of the months of April to june, 2012.

BE it enacted by the Legislative Assembly of the National Capital Territory of Delhi in the Sixty third Year of the Republic of India as follows:-

Short title.

issue of Rs.7742,50,00,000/from and out of the Consolidated Fund of the National Capital Territory of Delhi for the financial year 2012-2013

- 1. This Act may be called the Delhi Appropriation (Vote on Account) Act, 2012.
- 2. From and out of the Consolidated Fund of the National Capital Territory of Delhi, there may be paid and applied further sums not exceeding those specified in column (5) of the Schedule, amounting in the aggregate to the sum of rupees Seven thousand seven hundred forty two crore and fifty lakh only towards defraying the several charges which will come in the course of payment during the months from April to June, 2012 in respect of the services specified in column(2) of the Schedule.

Appropriation.

3. The sums authorised to be paid and applied from and out of the Consolidated Fund of the National Capital Territory of Delhi by this Act, shall be appropriated for the services and purposes expressed in the Schedule in relation to the said year.

STATEMENT OF OBJECTS AND REASONS

Sub-section (I) of section 29 read with clause (a) of sub-section (1) of section 30 of the Government of National Capital Territory of Delhi Act, 1991 (1 of 1992), provides for the appropriation out of the Consolidated Fund of the National Capital Territory of Delhi, of the moneys required to meet the additional expenditure charged on the Consolidated Fund made by the Legislative Assembly for the expenditure of the Government of National Capital Territory of Delhi. In pursuance of the aforementioned provisions of the said Act, it is proposed to introduce the Delhi Appropriation (Vote on Account) Bill 2012 for the expenditure of the Government of National Capital Territory of Delhi for the months of April to June, 2012, in the Legislative Assembly of Delhi for its consideration and approval.

2. The Bill is intended to achieve the aforesaid objectives.
