BILL

to authorise payment and appropriation of certain sums from and out of the Consolidated Fund of the National Capital Territory of Delhi for the services in respect of the months of April and May, 1994.

Be it enacted by the Legislative Assembly of the National Capital Territory of Delhi in the 45th Year of the Republic of India as follows:-

Short Title.

 This act may be called the Appropriation (Vote on Account) Act, 1994.

Vote on account for Rs.486,35,50,000/= out of the Consolidated Fund of the Govt. of National Capital Territory of Delhi for the months of April and May, 1994.

2. From and out of the Consolidated Fund of the National Capital Territory of Delhi, there may be paid and applied sums not exceeding those specified in column (5) of the Schedule amounting in the aggregate to the sum of four hundred eighty six crores thirty five lakhs and fifty thousand rupees, towards "Vote on Account" for defraying the several charges which will come in course of payment during the months of April and May, 1994 in respect of services specified in column (2) of the Schedule.

Appropriation.

The sums authorised to be paid and applied from and out of the Consolidated Fund of the National Capital Territory of Delhi by this Act, shall be appropriated for the services and purposes expressed in the Schedule in relation to the said
