

CIRCULAR

Kind attention of all Hon'ble Sitting MLAs is hereby invited to the OM No. F. 1(12)/H&FW/DGHS/4436-4686 dated 05.11.2019 issued by Directorate General of Health Services, GNCT of Delhi regarding Annual Health Check Up. A copy of the said circular is available on the website of DGHS. Accordingly, as desired by Hon'ble Speaker, Delhi Vidhan Sabha, the Hon'ble Sitting MLAs are also required to go for the Annual Health Check Up, as per the provision of the scheme. However, in order to ensure the same and for the purpose of proper regulation, Hon'ble Speaker (LAS) has desired that the Hon'ble Sitting MLAs shall undergo the check up between 1st to 15th Feb. each year. 
