MINUTES OF THE 17TH MEETING OF THE BOARD HELD UNDER THE CHAIRMANSHIP OF HON'BLE CHIEF MINISTER ON 28.09.2016 AT 03.00 P.M. IN THE CONFERENCE HALL NO.2, DELHI SECRETARIAT, NEW DELHI

At the outset, CEO, DUSIB welcomed all the participants and briefed about the agenda. He further sought permission of the Chair to start the meeting. After detailed deliberations on the items contained in the Agenda already circulated to the members, the following decisions were taken:

Agenda Item No. 17/1

Confirmation of minutes of the 16th Meeting of the Board

1. Minutes of the 16th Board meeting were circulated vide letter No.Meeting Cell/DUSIB/DD (Admn)2016/D-66 dated 18.04.2016 for the kind information of all the Board Members. No observation / comments have been received from any Member (s). Board confirmed the minutes of the 16th Board meeting.

Agenda Item No. 17/2

Action Taken Report on the Minutes of the 16th Board Meeting

1. CEO, DUSIB informed the members that actions on all the items have been taken and status report is placed for kind approval. The Board noted the Action Taken Report.

The Board considered the actual receipts and expenditures for the year 2015-16 and Budget Estimates for the year 2016-17 in respect of DUSIB and approved the budget proposals.

Agenda Item No.17/5

Relocation of JJ basti existing on NH-24 in the area of Vinod Nagar on the request of National Highway Authority of India to widen the NH-24

CEO, DUSIB informed the Board that about 410 JJ dwellers have been identified during the joint survey conducted by DUSIB and NHAI for relocation. The Hon'ble Dy. Chief Minister asked the basis for identifying only 410 although the number is much more in the two JJ Bastis coming in the way of widening of Delhi-Meerut Expressway (NH24). The Hon'ble Chairperson / Chief Minister directed the CEO, DUSIB to examine the proposal again and address the concerns raised by the Hon'ble Dy. Chief Minister before finalizing the proposal in accordance with the Delhi Slum & JJ Rehabilitation and Relocation Policy-2015.

Agenda Item No.17/6

Additional terms & conditions for granting permission to use of Basti Vikas Kendras for organizing community development activities

CEO, DUSIB informed that there are 317 BVKs, out of which 29 are fully vacant and 07 are partly vacant. He also informed that notices were issued to 125 allottee agencies for violation of terms and conditions of the allotment. He also informed that after examining the replies received from the allottee agencies, allotment of 20 BVKs has already been cancelled by DUSIB. Board appreciated the efforts of DUSIB in this regard and directed DUSIB to explore the possibility of using the vacant BVKs to operate Mohalla Clinic / Poly Clinic so that the vacant BVKs can be optimally utilized and also directed to not allot the BVKs unless a comprehensive view is taken for optimum utilization of the premises.



AGENDA ITEM NO. 17/6

ADDITIONAL TERMS & CONDITIONS FOR GRANTING PERMISSION TO USE OF BASTI VIKAS KENDRA'S FOR ORGANIZING COMMUNITY DEVELOPMENT ACTIVITIES

- 1. Under the plan scheme of construction of community hall/Basti Vikas Kendra (BVK), DUSIB is providing the facilities of BVKs in all existing JJ Clusters. Presently there are about 317 BVKs out of which 29 are fully vacant and 7 are partly vacant. These units of BVKs are allotted to Non-Governmental Organizations/Voluntary Organizations / Charitable Trusts for extending the facilities like health care, adult literacy, skill up-gradation, education, vocational programme etc to the JJ dwellers on license fee basis.
 - The existing terms & conditions for allotment to BVKs were approved in the fifth meeting of the Board held on 31.11.2011 and applicable w.e.f. 01.01.2012 which are as under:
 - i) The user organization will utilize the allotted space for the very purpose for which it has been allotted and shall not let out in any form, to any other organization/person.
 - ii) No alteration/addition/construction shall be made in allotted accommodation.
 - iii) The user organization shall deposit Rs.10/-per sq. feet with minimum Rs. 10,000/- as security amount (refundable) in the favour of DUSIB. In the event of violation of any terms & conditions, the security amount will be forfeited.
 - iv) The permission is purely on provisional and temporary basis on nominal License fee @ Rs. 2/- per sq. feet per month. In the event of non-payment of License fee, permission to use BVK will be cancelled.
 - v) The user organization will vacate the BVK whenever required for official work/any government work without any demure / resistance. The organization will have no right to claim any kind of compensation whatsoever.
 - vi) The user organization shall be responsible for safe custody of furniture and fixture and cleanliness of the premises. The organization will also bear electricity and water charges. The periodical maintenance of the building however will continue to vest with DUSIB.

- vii) NGO/Charitable Trust will carry out community development activities on no profit and no loss basis and will submit annual income and expenditure statement.
- viii) The allottee organization shall maintain a socio-economic data of the concerned slum/JJ colonies concerned.
- ix) The allottee organization shall furnish reports of the activities carried out in Basti Vikas Kendra to the DUSIB on every six months.
- x) The officers of the DUSIB shall have the authority to inspect BVK time to time to see activities being organized and the user organization shall provide all necessary information in respect of such activities.
- xi) That nothing herein contained shall be construed as conferring upon user organization any right or title or interest in BVK.
- xii) NGO/Charitable Trust will encourage local JJ dwellers to take part in the management and ongoing welfare activities being carried out in the BVK.
- xiii) The DUSIB reserves the right to cancel permission to use BVK. The Decision of CEO (DUSIB) will be final.
- xiv) Priority for allotment of BVK will be given to NGO's/ organization having recommendations from Local MLA.
- xv) Existing NGO's coming for renewal of their term will be covered as per new terms and conditions on certificate of satisfactory performance.
- 3. In order to streamline the functioning of BVKs, additional terms & conditions were also placed in the 11th Board meeting dated 16.09.2014. After discussion, only one condition was approved in the 11th Board meeting i.e. the applicant shall deposit six months advance License fee twice in a financial year i.e. by 10th of April for the period starting from April to September and by 10th October for the period starting from October to March of respective year along with Activity Report for the past six months. No separate demand notice will be issued for License fees in routine manner. For other additional terms & conditions the board directed to re-examine the other terms and conditions to make them effective. In compliance of the direction of the Board, a proposal regarding additional terms & conditions in policy for granting permission to use BVK for organizing community development activities was placed before the CEO in the relevant file.

4. As per directions of CEO, this issue was considered by High Level Coordination Committee of DUSIB in its meeting held on 19.04.2016 and recommended as under:

"The existing terms & Conditions for allotment of BVK have already been approved by the Board in the 5th & 11th meeting of the Board. For rationalizing the allotment of BVK available all over Delhi, there is need for additional terms & conditions to be incorporated for allotment of BVK which are also to be placed before the Board for final approval."

- 5. After detailed deliberations, the committee proposed the additional terms & conditions for allotment of BVK with some suggestions. The following additional terms & conditions are placed before the board for consideration & approval please.
 - (i)Applicant shall provide two guarantors/Sureties (other than family member) along with their Aadhar Cards for necessary legal formalities. In case of failure in depositing the outstanding dues, the same will be recovered from these guarantors/Sureties.
 - (ii)The allotment shall be liable to be cancelled in case of violation of terms & conditions. The NGO shall deposit up to date dues and hand over the premises to the concerned Executive Engineer. In case of failure, the premises shall be taken over by the Department by force and Department shall not be responsible for articles/belongings lying in the BVK.
 - (iii)The permission is purely on provisional and temporary basis on license fee @ Rs.3/- (Rupees three) per sq. feet per month (from existing Rs.2 per sq feet per month fixed in year 2011) and security may be fixed Rs.15,000/- (proposed for enhancement from minimum Rs. 10,000/-) per BVK per Allotment and six months licence fee may be deposited in advance.
 - (iv)In cases where the outstanding dues are not recovered, the recovery be made under the relevant laws. The entire cost of such recovery shall be borne by the allottee. Intimation in this regard will be sent to the Registrar of the Society /Trust for BLACK LISTING and attachment of assets of the officer bearers.

(v)In Any dispute related to allotment of BVK including payment of license fee or any outstanding dues, the decision of CEO, DUSIB will be final.

(vi)NGO/User organization shall install separate pre-paid power meter & water connection. DUSIB will not be liable for any outstanding dues in this regard.

- 6. While considering the allotment of BVK in Rajasthani Camp, Sarita Vihar, it was decided to streamline the procedure of allotment of BVK's and therefore, following will be considered at the time of allotment:-
 - (i)Non-Governmental Organization / Voluntary Organization / Charitable Trust / Resident Welfare Association/Govt. office will submit 'aims and objectives' at the time of allotment of BVK.
 - (ii)Track Record of the activities being done by Non-Governmental Organization / Voluntary Organization / Charitable Trust/Resident Welfare Association /Govt. office and proposed action plan for 1-2 years.
 - (iii)The Non-Governmental Organization / Voluntary Organization /Charitable Trust/Resident Welfare Association/Govt. office will submit the detail of educational/professional background of its members and give a presentation, if so required.
- **7.** Board is requested to approve the additional terms and conditions as delineated in para 5 and 6.

At the outset, CEO, DUSIB welcomed all the participants and briefed about the agenda. He further sought permission of the Chair to start the meeting. After detailed deliberations on the items contained in the Agenda already circulated to the members, the following decisions were taken:

Confirmation of the Minutes of 22nd Meeting of the Board held on 13.07.2018

Minutes of the 22nd Board meeting were circulated vide letter No. Meeting Cell/DUSIB/DD(Board)20178D-17 on dated 25.7.2018.

(i) CEO, DUSIB informed the members that in the minutes of 22nd Board Agenda Item Nos. 22/31, 22/32 & 22/32 the approval was obtained for 'Forfeiture of gratuity' inadvertently. This may be amended by substituting the words 'Withholding of entire gratuity' instead of 'Forfeiture of gratuity' as the forfeiture applies to those who are removed/dismissed from service whereas all three officers stand retired.

The Board considered and approved the amendment in the minutes.

(ii) CEO, DUSIB informed about the observation of Shri Sahi Ram, Hon'ble MLA/Member dated 23.8.2018 that the issue regarding use of BVK for MLA office was decided in the Board for one specific request and not in general to use BVK's for MLA offices only on the request from Delhi Vidhan Sabha. It was agreed to that such requests will be considered on case to case basis and after approval by Hon'ble Minister (UD)/Vice Chairman, DUSIB.

Agenda Item No. 23/5

Policy for regularization of Coal Depots allotted on licence fee basis and then cancelled by the erstwhile Slum & JJ Department (now DUSIB) of policy.

The Board deliberated the issue in detail and decided to charge the current circle rates for regularization of coal depot from the original licensees and 20% penalty on the purchasers in respect of the rest of 85 Coal Depots of DUSIB. While following this principle a detailed proposal will be made for approval in the next Board meeting.

Agenda Item No. 23/6

Shifting of the occupants of the CPWD Kothi No.23, 25, 27 & 29 Barron Road, Minto Road and to hand over the site to the M/s Indraprastha Gas Ltd. in compliance of Hon'ble High Court, Delhi order dated 26.07.2016.

The Board discussed in detail the proposal and decided to follow the existing policy of allotment of flats to eligible beneficiaries.

Agenda Item No. 23/7

Conversion of ways and means loan provided by Government of NCT of Delhi to DUSIB into grant-in-aid.

ACCORD OF NECESSARY PERMISSION TO USE THE VACANT SPACE OF BASTI VIKAS KENDRAS FOR ORGANIZING SOCIAL AND COMMUNITY FUNCTIONS THROUGH BOOKING ON THE SIMILAR PATTERN ADOPTED FOR COMMUNITY HALL.

- 1. In accordance to the decision taken by the board during its 17th Meeting held on 28.09.2016 vide agenda item no.17/06 i.e. "Board appreciated the effort of DUSIB in this regard and directed DUSIB to explore the possibilities of using vacant BVK's to operate Mohalla Clinic/ Poly Clinic so that vacant BVK's can be optimally utilized and also directed to not allot the BVK's unless a compressive view is taken for the optimum utilization of the premises". DUSIB has put on hold the further allotment of BVK till a final view of the Government.
- 2. Under the approved Plan Scheme of Construction of Community Hall / Basti Vikas Kendra, DUSIB (erstwhile Slum & JJ Department) is providing the facilities of BVK's in all existing JJ clusters. The Basti Vikas Kendras of DUSIB are built up for rendering the community services to the people living in nearby JJ Basties. Some of these are built up and some are temporary structures being operated and managed by the Engineering Wing of DUSIB having big/small rooms at various Floors. These BVKs have been allotted to various NGOs / Voluntary organizations / Charitable Trusts, Govt. Organization for extending the facilities like Health Care, Adult Literacy, skill up gradation, educational, Vocational programmes etc. to the JJJ dwellers. The allotment of BVK to allottee agencies is being made @ Rs.02 (Two) per square feet per month + Rs. 10000/- towards security (refundable) one time on license fee basis.
- 3. Presently there are 320 nos. of Basti Vikas Kendras (BVKs) maintained by DUSIB and out of which 40 nos. of BVKs are vacant. These vacant BVKs may be considered for daily basis booking for the residents of the JJ Basties for their social functions on nominal booking charges.
- 4. During the various meetings held with Hon'ble Area MLAs the issue of allotment of BVKs discussed on time to time and demanded early allotment/proper utilization. In the recent meeting held with Hon'ble Area MLA AC-14, Shalimar Bagh Ms.Bandana Kumari it was requested that till the final view/outcome, on this issue the vacant space of BVKs in her constituency be allowed to organize social/community function as the dwellers of that area are facing hardship in absence of their proper utilization of these buildings. Moreover DUSIB may charge the booking amount from the dweller on the similar pattern as adopted for the booking of Community Hall in that area/zone.
