



Sub:- Regarding putting immediate hold on activities under UTTIPEC Project in AC-23, Karol Bagh and resuming the same after ensuring compliance of chronological activities as designated in the UTTIPEC Project.

Ref:- Your office letter No. 119590/13/7/2021 dt. 13.07.2021

महोदय,

With regard to the your above cited letter on aforesaid subject the details of footpath up gradation work on various roads of Karol Bagh are detailed below. The Traffic management & Heritage conservation plan of Karol Bagh zone was approved in the 22nd UTTIPEC Governing body with file no. P6 (119)/09/UTTIPEC, date of uploading on website 16/01/2015. The UTTIPEC Governing body approved the parking and traffic circulation system around the purposed Ajmal Khan pedestrian/ non motorised street. As per approved UTTIPEC plan parking capacity is to be increased by MCD and Delhi Traffic Police will implement one way traffic circulation on different roads of Karol Bagh. The high power committee on traffic management in Delhi of MHA appointed knowledge Partner to Sh. Anuj Malhotra and Ms Paromita Ray vide order no. 14014/49/2018-UTP.

To implement the pedestrian plan of Ajmal Khan Road and surrounding roads of Karol Bagh, the Commissioner of North DMC had written a letter to Principle Chief Engineer, PWD vide no. D-309/CMR/NDMC/CC/2019 Dated 06/08/20219 to upgrade the footpath of different roads of Karol Bagh. Further a meeting was held between Engineer in Chief, PWD, the Commissioner North DMC, DCP Traffic Police in August 2019 to discuss the above issue of Karol Bagh and decided that PWD will upgrade the footpath at different roads of Karol Bagh. As per drawing issued by the Knowledge Partner of MHA. As per above letter of the Commissioner North DMC total 16 different roads of Karol Bagh to be upgraded including Ajmal Khan Road. Out of total 16 roads, the some portion of 12 nos. roads are under the jurisdiction of PWD division SWR1 and the footpath work on that portion has not started in division SWR1. As per drawing each road except Ajmal Khan Road has provision for parallel parking space of width 2 mtrs on both side between carriage way and footpath.

The estimate for the above work was prepared as per drawing of Knowledge Partner of MHA and A/A & E/S received. Further the tender where called by compiling the A/A & E/S of the other resurfacing work of Division Office and work awarded to agency M/s M.C. Construction Co. The above work is in progress on different roads as per drawing of Knowledge Partner of MHA. The status of running work on different roads are as per details mentioned below:-




