

Report regarding Surajmal Stadium

A visit of Surajmal Stadium, Nangloi was made by undersigned on 18.01.2018 alongwith Sh. Sanjay Kumar, Section Officer, Sh. Mukesh Dabas of Sports Branch and officers of PWD (Education Project Division) & D.D.A. (Sports Division-2) to assess the feasibility of taking over of stadium. During the inspection, Sh. P.K. Talwar, Ex. Engineer, Sports Division-2, D.D.A., Sh. R.L. Kaushik, A.E. Sports Division-2 DDA. were present from D.D.A.. Sh. Karamvir Singh Ex. Engineer, Education Project Division & Sh. Rajved, A.E. Education Project division were representative of Education Project Division of PWD.


The representative of D.D.A. stated that the stadium has playing field of Football cum Cricket, Basketball, Skating Ring, Volleyball, Tennis Lawn (and Jogging Track. It was also informed that there is G.I. Water Supply Pipe Line of 2.5 Inch running underground through the stadium. On enquiry, it was stated by them that the land is free from any litigation and encroachment. At present there is no provision of Security and Sanitation at the stadium. Only two employees of Horticulture Division of D.D.A. are employed at the site for maintaining the ground and stadium. Also, no drinking water facility is available at the site. Apart from that , a defaced statue of Maharaja Surajmal is also there. Representatives of D.D.A. stated that the tender for the statue has already been flouted and same will be beautified soon. A copy of the layout map was also handed over by D.D.A. officers.

During the inspection, it was found that only Football field is in operational condition although the same requires leveling and grass work. There are no coaches/ supporting staff employed to provide any coaching related to sports. Also, there are no rooms/ office to maintain the facilities.

(The site was found to be conducive for developing Sports Center but will require major development work as the present facilities are in depilated condition. In the existing set up, Football, Basketball & Skating facilities may be developed for which manpower for Coaching, Security, Sanitation etc will be required throughout the year. At present there is no Toilet Block & Changing Room in the stadium.)

At present there is no Sport Facility of Sports Branch in the area. Venue is easily approachable due to connectivity of Main Rohtak Road and Metro Station which incidentally is named Surajmal Stadium. Once, the stadium is developed, it will cater to the needs of not only Nangloi Area but will also cater to the needs of area adjoining Mundka, Tikri, Kirari , Peeragarhi & Sultanpuri.
