Please refer your letter No. OSD/Dy.C.M /2019/7644-45 dated 08.11.2019, enclosing the letter of Sh. Som Nath Bharti, MLA (Malviya Nagar) requesting to develop a World Class Skill Centre by up gradation of ITI Malviya Nagar, which falls under in his constituency.

In this regard it is stated that 25 World Class Skill Centres were to be launched, out of which this Dte. has already started 6 WCSCs in phase-I w.e.f. session March-2019, and 19 WCSCs will be started shortly. Presently, no proposal to develop the ITI Malviya Nagar as World Class Skill Centre is under consideration.

However, it is mentioned that, one WCSC i.e. WCSC, DPSRU of phase-I which is already in operation is 5.6 km. and 3 other WCSCs of phase-II which are likely to be started shortly i.e. WCSC Jlja Bai, ITI, Slri Fort is 2.4 Km., WCSC DITE Okhla is 8.3 Km. and WCSC G B Pant IT is 6.3 Km. for from the Malviya Nagar
