The Delhi Assembly proposes to hire the services of reputed and experienced agencies / vendors to provide telecast quality live HD feed of the Assembly Proceedings and other events to be held in the Assembly Complex.

The Assembly proceedings are held in a closed Hall whereas the other events are held in conference rooms or outdoors. The agency / vendor is expected to be flexible in accommodating additional requirements, such as one or two additional cameras or longer cables etc., on short notice as and when necessity arises. On an average the Delhi Assembly sits for 25 days in a year, spread over different months, and is expected to hold approximately five to ten events (including outdoor events) during a year. The agency / vendors have to quote their rates on 'per day' basis (inclusive of all taxes). They are also expected to comply with all statutory requirements for providing these services and should be registered with the concerned agencies.
