Minutes of Meeting

As meeting was held under the Chairmanship of Spl. Secretary-I (UD) to review the pending projects/works under MLALAD Scheme and MSPY Scheme with various Executive Agencies on 31.10.2023. Earlier meetings on 26.06.2023 and 24.08.2023 were also held on the same issue but no result/outcome has been received yet.

The list of officers who attended the meeting is enclosed.

At the outset, Spl. Secretary-I (UD) apprised to all the Executive Agencies that many Hon'ble MLAs have raised the issue regarding savings and brought to the notice that the works under MLALAD and MSPY Schemes are pending since long and their monitoring in this regard is required at the end of the UD Department.

The following issues were discussed:

i. It was discussed that all the Executive Agencies shall submit the completion/utilization certificate of the works sanctioned before 31.03.2023 in the first instance so as to ensure that all the pending works sanctioned under both the Schemes are brought to the completion level in the record of UD Department.

(Action: All Executive Agencies)

ii. It was pointed out by Dy. Director (MSPY) that the Executive Agencies have been submitting Utilization Certificate in the old format i.e. Form 19 A (GFR 2005) whereas they should submit the Utilization Certificate as per Form 12-A of GFR 2017, which specifically provides for the details of interest earned on unspent balances of grants and interest deposited back to the Government. All the Executive Agencies were directed to strictly adhere to the guidelines as per GFR 2017.

(Action: All Executive Agencies)

iii. All works for which 50% of the estimated amount was released as a first installment till 31.03.2023, it was decided that if the bills for second installment are not received from the Executive Agencies within 30 days, in such cases it shall be presumed that no fund/2nd installment is required and remaining 50% fund shall be credited to the MLAs accounts/no provision is kept in MSPY fund for those works.

(Action: All Executive Agencies)

iv. All works for which 75% of the estimated amount was released as a first installment till 31.03.2023, it was decided that if the bills for second installment are not received from the DISCOMs within 20 days, in such cases it shall be presumed that no fund/2nd installment is required and remaining 25% fund shall be credited to the MLAs accounts/no provision is kept in MSPY fund for those works.

(Action: All DISCOMS)

v. It was also decided that letter to all the Executive Agencies may be sent stating that if no more fund is required, then the balance fund shall not be released and the same shall be credited to the accounts of Hon'ble MLAs.

(Action: UD Department)

vi. If the Executive Agencies do not adhere to the deadline then this issue may have to be brought to the notice of Public Accounts Committee, Delhi Vidhan Sabha, as the issue was considered in its proceedings dated 02.05.2023.

(Action: UD Department)

Further, it was also discussed that all works for which 50% of the estimated amount was released as a first installment till 31.03.2023, on the basis of preliminary estimates and their bills for second installment have not been received from the Executive Agencies, in such cases it shall be presumed that no fund/ 2^{nd} installment is required and remaining 50% fund shall be credited to the MLAs accounts and/or directed to the Executive Agency to refund it by 31.12.2023 without fail.

Urban Development Department, GNCT of Delhi is releasing funds to the various executive agencies like MCD, PWD, DSIIDC, I&FC, BYPL, BSES, DJB etc. under MLA Local Area Development Scheme (MLALAD) since, 2017. Earlier, the scheme was managed by DUDA.

On scrutiny of the record, it is revealed that after receiving of 50% amount as 1st instalment of the proposed/sanctioned project, the executive agencies is not submitting the proposal for balance amount since long. The time period for completion of the projects under MLALAD Scheme in most of the cases is only 2 to 6 months. However, after lapse of over 2 to 5 years executive agencies are not interested to submit the final proposal in this department.

Due to this, Urban Development Department is unable to carry forward the savings to the account of Hon'ble MLAs. This department has earlier requested the executive agencies to give preference to the final proposal under MLALAD Scheme. However, the response is not received from any of the agency.

The matter was discussed in the PAC meeting held on 02/05/2023 wherein it was decided to forward a list of those proposals which are kept pending in various executive agencies for release of final payment to the Hon'ble MLAs and the concerned Executive Agencies with the request to submit the final proposal immediately.

Further, a revised checklist has been prepared (copy enclosed) which needs to be filled by the Executive Agencies at the time of submitting the proposals for 1st installment.
