


Sub: Policy on the shifting of HT (11KV, 33KV & 66KV) / LT400V)  
Electricity Transmission Lines posing threat to human lives –  
Modification of Cabinet decision No.1588 dated 09.11.2009 thereof.

The Council of Ministers, Govt. of NCT of Delhi vide decision no. 2604 dated 31.07.2018 on the subject cited above has considered and approved the following in respect of the existing policy on shifting of HT/LT Lines:

- i. In case of colonies set up under 20 point programme in the rural area, the shifting of HT/LT lines would be done through the fund of Govt. from the budget of Power Department which would provide for 100% of the cost of shifting.
- ii. In respect of other rural areas, like Lal Dora areas and extended Lal Dora areas, the cost of shifting of HT/LT lines would also be made from the funds of Govt. from the budget of Power Department which would provide for 100% of the cost of shifting.
- iii. In respect of farmhouses, the entire cost of shifting will be borne by the affected consumers. In case of farmers other than farmhouse owners, 100% of the cost of shifting is to be borne by Govt. from the budget of Power Department.
- iv. In respect of regularized unauthorized colonies including urbanized villages and resettlement colonies, 100% of the cost of shifting is to be borne by Govt. from the budget of Power Department.
- v. In case of HT/LT lines passing through Government Institutions, public authority buildings, schools, hospitals, colleges of public nature and

which are owned by the government, 100% of the funding would be met by the concerned department/ agency for shifting of the lines.

- vi. In case of private institutions of a public nature like educational and health institutions etc., 100% of the cost of shifting is to be borne by the concerned institution.
- vii. Scope of the policy of HT/LT lines will include the HT transmission lines of 11KV, 33KV as well as 66KV and LT lines of 400V.

Sub: Policy on the shifting of HT (11KV, 33KV & 66KV) / LT(400V) Electricity Transmission Lines posing threat to human lives – Modification of Cabinet decision No.2604 dated 31.07.2018 thereof.


The Council of Ministers, Govt. of NCT of Delhi vide Decision No.3105 dated 07.02.2023 has considered and approved the following in respect of the existing policy No. F.11(09)/2007/Power/2609-2619 dated 03.08.2018 on shifting of HT/LT Electricity Transmission Lines posing threat to human lives:

i. The clause-V of existing policy of shifting of HT/LT lines dated 03.08.2018 has been modified to the following extent:

*In case of HT/LT lines passing through Government Institutions, public authority buildings, public schools, public hospitals, colleges of public nature and which are owned by the government, 100% of the funding would be borne by the Power Department GNCTD (under intimation to the land-owning agency concerned) in order to avoid further casualties for shifting of the lines, subject to the condition that 'No Objection Certificate' has been obtained from the concerned land-owning agency for undertaking such work of shifting of lines.*

ii. A new clause in existing policy of shifting of HT/LT line dated 03.08.2018 has been added:

The Expert Technical Committee (ETC) would assess the proposals of shifting of HT/LT lines and certify that the existing electric line proposed for shifting pose threat to human lives.

**ORDER**

**Subject: Policy on shifting of HT/LT Lines in Unauthorised Colonies; Cabinet Decision No.2604 dated 31.07.2018, reg.**

The Council of Ministers, considering the note of Secretary (Power), vide the Cabinet Decision No.2604 dated 31.07.2018, has approved the Policy of shifting of HT/LT lines by extending the scope thereof so as to include the shifting of HT 66KV electricity transmission lines in the existing Policy of 11KV & 33KV HT lines and also that the projects of shifting of HT/LT lines will be considered in all the Unauthorised Colonies. In lines with the Cabinet Decision No.2604 dated 31.07.2018, the order of Urban Development Department dated 28.06.2016 also stands ratified.

Pursuant to the Cabinet Decision No.2604 dated 31.07.2018, the modalities for processing the proposal of shifting of HT/LT lines would, henceforth, be governed as follows:-

1. The proposal for shifting of HT (11KV, 33KV & 66KV)/LT400V lines in un-authorised colonies will be funded by Urban Development Department under the plan scheme "Provision of Essential Services in Un-authorised Colonies."
2. The projects of shifting of HT/LT lines will be considered in all the un-authorised colonies in terms of the Development Guidelines/orders as are applicable and issued from time to time.
3. The Hon'ble MLAs will send specific proposal to Power Department. The Power Department will obtain technical feasibility report along with the estimates from DISCOM concerned and make their recommendations to the UD Department.
4. The UD Department will release funds to Power Department for execution of the scheme/Project as per their recommendations.
